Terms and Conditions :

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates must have registered their names in the Employment Exchange and the Registration numbers along with date must be mentioned in their applications.
3. Candidates serving in Govt. Department should submit their application through proper channel.
4. Candidates must have passed Class VIII and up to Class - XII. **Candidates, who have completed graduation or above shall be ineligible to apply for the aforesaid posts.**
5. Candidates must not be less than 18 years or more than 38 years of age on 01-01-2018. The upper age is relaxable as per Govt. norms.
6. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card, Professional Driving License, Experience Certificate & Character Certificate (wherever applicable) along with 3 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side should reach the Office of the undersigned.
7. The applicant for the post of Driver must have a **valid Professional Driving License** (Transport) with **Experience Certificate** (for more than 3 years) and **Character Certificate**.
8. The applicants shall mention their Mobile Numbers in the application without fail.
9. The last date of receipt of application is **12-11-2018**. No application will be entertained after the last date. The appointing authority shall not be responsible under any circumstances for any postal delay.

10. Candidates intending to apply for different posts shall submit separate applications.
11. Envelope containing application should indicate the name of the post applied for on the top in Block letters as – "APPLICATION FOR THE POST OF _____".
12. The eligible candidates (applying for Sl. No. 2 and 3) shall be required to appear for written test, followed by viva-voce.
13. The eligible candidates (applying for Sl. No. 1) shall be required to appear for skill test, followed by viva-voce.
14. The list of eligible candidates along with specific dates of interview shall be uploaded in the Official website of Sonitpur District Judiciary in due course (www.sonitpurjudiciary.gov.in). **No separate call letters will be issued.** Applicants are requested to refer to the official website.
15. Written test will comprise of 100 Marks followed by Viva-voce of 20 marks. The syllabus for the written test will be Assamese, English, General Knowledge and Reasoning & Aptitude. Skill test for the post of Driver will comprise of 30 Marks followed by Viva-Voce of 20 Marks.
16. Interview Centre : Tezpur (Date & Venues will be informed in the Official Website).
17. No TA/ DA will be admissible to the candidates for attending the Written Test / Skill Test / Interview Process.
18. Application received late or without proper supporting documents or unsigned or incomplete will be summarily rejected.
19. Canvassing directly or indirectly shall disqualify a candidate.
