#### General condition:-

- Age not exceeding 28 years of JRF as on date of interview (upper age limit relaxable upto 5 years in case of candidate belonging to SC/ST, female candidates, 3 year in case of OBC category) those belongs to SC/ST/OBC are required to produce the Original Caste Certificate issued by Competent Authority.
- The above position is purely temporary initially for a period of 06 months and will be co-terminous with the requirements of Oversight Committee constituted by Hon'ble National Green Tribunal in O.A. no. 670/2018 Atul Singh Chauhan Vs. Ministry of Environment, Forest & Climate Change and Ors. The services of the selected candidate will stand terminated automatically subject to requirement of Oversight Committee. He/She will not have any right to claim for regularization or absorption whatsoever in regular vacancies of Uttar Pradesh Pollution Control Board (UPPCB).
- UPPCB has full right to terminate the services of JRFs at any point of time.
- TA/DA will not be admissible for attending the interview.
- Recruitment will be made through INTERVIEW, however, relevant documents/mark-sheet including experience certificate would be verified and screening would be made. Candidates would be selected on the basis of suitability.
- The Board reserves the right not to fill up the above advertised post, if so decides, no correspondence/ representation will be entertained in regard to the walk in interview and/or selection.
