A. ELIGIBILITY CRITERIA / QUALIFICATIONS

DEMONSTRATOR / CLINICAL TUTOR:

Post Graduate degree [MD/MS or DNB or equivalent PG Degree (as per MCI Norms)] in concerned discipline

B. Cutoff date for experience & qualification: 01.09.2020.

C. Age Limit:

For DEMONSTRATOR / CLINICAL TUTOR - Age as on **01.09.2020** should be **less than 45 years** (Provided that age relaxation may be given for the candidates belonging to the categories of SC, ST and other Backward Classes as per Government Rules or Orders issued from time to time; Relaxation may also be given in exceptional circumstances)

D. Scale of Pay:

Application received after the closing date shall be rejected. Application not duly filled in or found incomplete or defective in any respect or without fee will be liable to rejection. Applicants do not need to send any print out/ hard copy.
2. Any attempt on the part of candidate to enlist support for his/her application through persons, officials of Government, or agencies will disqualify him/her for appointment.
3. The candidates are required to deposit a non-refundable fee of **Rs. 500/- and Rs. 250/-** for General and OBC candidates respectively, online in the account mentioned below:

Money order, cheque, bank draft, cash etc. will not be accepted. No application shall be considered unless accompanied with the requisite application fee.

4. Candidates belonging to SC/ST and persons with disabilities specified under Disabilities Rule, 1999 (certificates obtained before the Advertisement date) are not required to pay any fee.
5. No claim for refund of the fee shall be entertained nor will it be held in reserved for any other interview. No TA /DA are given if called for Interview.
6. Employees of Government / Semi Government/ Private should inform their employer before appearing in the Interview. A copy of **No Objection Certificate from employer** must be scanned & emailed along with other documents. It is to be mentioned in NOC that candidate will be released if selected after serving requisite notice period if any.
7. A candidate claiming to be S.C. /S.T. must have a certificate in support of his/her claim from a competent authority.
8. OBC candidate of West Bengal should submit valid '**Non creamy layer**' certificate issued after **01.01.2020**.
9. Persons with Disabilities (PWD) [40% and above] must have a certificate from an appropriate Medical Board.
10. No claim for being a Member of the SC, ST and OBC or a Person with Disability will be entertained after submission of the application.
11. Candidate, if selected, have to join in the said post within **01 (one) month** from date of issuance of date of appointment, after verification of all original documents at WBUHS.
12. The post is full time. Nature of appointment is regular; confirmation of service will be made after satisfactory completion of **one year of probationary period**.
13. **Three months notice** needs to be served from either side before termination of service.
14. A candidate should note that his/her appearance in the Interview will be deemed provisional subject to determination of his/her eligibility in all respects. If at any stage even after issue of the letter of appointment a candidate is found ineligible, his/her candidature will be cancelled without further reference to the candidate.
