The post of **One (01) Stenographer** in the Court of Additional District and Sessions Judge, Fast Track 1st Court, Paschim Medinipur and the post of **One (01) Group-D** in the Court of Additional District and Sessions Judge, Fast Track 2nd Court, Paschim Medinipur are lying vacant w.e.f 01.09.2020 and one **(01) post of Bench Clerk-I** in the Court of Additional District and Sessions Judge, 7th Court, Paschim Medinipur is lying vacant w.e.f. 01.10.2020.

As per G.O. No. **180 JD/L-2S/135/02** pt. II dated-25.03.2013 and G.O. No. **61JD/L/25/135/02** pt. -II dt-30.01.2013 with the concurrence of the Finance Deptt. **U.O. No. 2992** Group-P (Service) dt-28.09.2012 and approval of the Cabinet vide U.O. No. Cab (D)-1043 dt-08.12.2012, the Govt. has approved the Fast Track Courts in the Judgeship of Paschim Medinipur to be run as permanent features of administration.

And

In view of No-**393-JD/X/1E-18/14** of the Govt. of West Bengal, Judicial Department, Writer's Building, Kolkata-700001 the recruitment and fixation of pay of the staff of the Fast Track Courts would be made following the provisions of Judicial Department No. 671J dt. 14.09.2001 and 10408 (17)-J dt. 27.11.2001.

And

Vide Notifications No. 04/2020 dated 23-09-2020 this Office invited applications from the eligible persons for the appointment to the above mentioned vacant posts scheduling 15-10-2020 as the date for an walk-in-interview.

And

As it appears that there were insufficient number of candidates/Applicants who applied pursuant to this Office's Notification no. 04/2020 dated-23.09.2020, with a view to ensure adequate numbers of Candidates / Applicants for the sake of fair competition, the scheduled interview as per the said Notice was deferred till another suitable date appreciating the COVID-19 situation followed by a fresh notice inviting further applications without prejudice to the candidates who had already applied.

Now, since the COVID-19 situation is gradually improving and there is also availability of adequate transport, a further notification is required in furtherance with earlier notices as hereunder:-

The said posts to be recruited by the District and Sessions Judge, Paschim Medinipur from the persons who retired from the Government service **not earlier than 01.09.2019** subject to the condition that they are physically fit and mentally alert. The applicants will have to produce the medical certificate of fitness of the authority concerned.

Appointment would be made on contract basis and contract pay of retired personnel staff as per following formula subject to the approval of the Government on usual terms and conditions of re-employment in terms of Finance Department Memo No- 3951-F dated-27.05.2009 and G.O. No. -208(18)-J dated-09.01.2008.
