(PB4 ₹37400 - 67000, Grade Pay: ₹8700 as per 6<sup>th</sup> CPC)

**Age Limit:** Not more than 55 years

**Educational & Other Qualification:** Bachelor's Degree in Civil Engineering with 15 years' experience out of which at least 9 years must be at the Executive Engineer level.

**Desirable:** Experience in design, estimation and execution of Civil Engineering works, supervision of construction of multi-storied buildings, maintenance of buildings & roads in Govt. or Govt. undertakings/ PSU/ National level Institutions.

**Pay Level:** 10 (as per 7<sup>th</sup> CPC)  
(PB3 ₹15600-39100, Grade Pay: ₹5400 as per 6<sup>th</sup> CPC)

**Age Limit:** Below 50 years

**Educational & Other Qualification:** Post Graduate qualifications in an appropriate discipline from accredited and recognized Institutions with specializations in areas of Counselling, Psychotherapy and / or Clinical Psychology.

**Desirable:** At least 3 years experience as practicing professional or as in-house counsellor. Experience of similar work in higher educational institutions will be given weightage.

### 4. SENIOR SECURITY OFFICER – 01 post (UR)

**Age Limit:** Not more than 55 years

**Method of Recruitment:** Direct Recruitment (with provision of deputation) for a tenure of 5 years.

**Educational & Other Qualification:** Commissioned Officer of Military or Para-Military Services / Deputy Superintendent or Assistant Commandant of Police/Security Force having a Bachelor's degree from a recognized university with at least 5 years' experience in the Police/ Security Services.

**OR**

Junior Commissioned Officer at the level of Subedar Major of Military / Para Military Services or Inspector of Police having a Bachelor's degree from a recognized university with at least 15 years' experience.

**OR**

A Bachelor's degree from a recognized University with at least 50% marks in the qualifying degree with overall 20 years relevant experience in security service in University / Central Autonomous Body / CFTI / PSU, out of which at least 5 years' experience in the Pay Level – 8 (Pay Band-2 Grade Pay of ₹4800/- as per 6<sup>th</sup> CPC) or its equivalent.

**Retired person may also apply.** Their candidature will be considered in absence of sizable number of suitable candidates from amongst applicants from the above mentioned criteria. However, in case of such candidates, the term of appointment shall not go beyond 5 years after the age of superannuation. If selected, the candidates from this category will be paid a consolidated sum of ₹ 60,000/- per month with an annual increment of ₹ 2,000/-.

**Desirable:**

1.	Applicants will have to make payment of a non-refundable application fee through online mode only. Fee payable by the applicant are as follows: ₹500 (for Unreserved and OBC applicants) & ₹250 (for SC/ST/PwD applicants). Women applicants are exempted from payment of application fee.
2. (IST) on 15 December, 2021. <b>Last date of receipt of online application: 24.01.2022 till 5 P.M. (IST).</b>
3.	The date for determination of age will be as on 24.01.2022.
4.	Relaxation of age for SC/ST/OBC/PwD/Ex-Serviceman will be as per GOI rules.
5.	Reserved category applicants shall be required to upload the latest Caste certificate issued by the Competent Authority as per Govt. of India directives issued from time to time. Applicants belonging to OBC(NCL) category will have to upload OBC(NCL) certificate otherwise, such applicants will be considered as unreserved category applicants. Similarly, PwD applicants shall be required to upload proof of disability mentioning the percentage of disability issued by the Competent Authority.
6.	The applicant will be responsible for the authenticity of submitted information/documents and photograph. It is the responsibility of the applicant to assess his/her own eligibility to the post in accordance to the advertisement, if it is detected at any time in future, during the process of selection or even after appointment that the applicant was not eligible as per the prescribed Recruitment Rule of the Institute which could not be detected at the time of selection for whatsoever reason, his/her candidature/appointment shall be liable to be cancelled/terminated immediately.
7.	Mere fulfilling the conditions does not guarantee that the applicant will be shortlisted for interview.
